## Internet and Computer Use

Copies of the library's Internet Safety Policy, and the Library's Internet and Computer Use Policy are available at the Service Desk.

At any time that I use the library's computers I agree to comply with the Internet and Computer Use Policies, including the Internet Safety Policy.

PINES card holders should present their library cards to be issued a computer.

Computer users 17 and older may request use of an unfiltered Internet computer.

All users of the library's computers are to follow the library's policies and related to sending electronic mail, instant messages, or chat room messages that violate any local, state, or federal laws.

Computer user will download NOTHING to the hard drive.

One person per computer unless space allows.

Only the person who is signed onto a computer may use that computer.

Computer users must pay for all copies printed during their computer sessions.

Computer users may not install, customize, or reconfigure software on a library computer and may not alter the library's computers or network hardware in any manner.

Violations of these and other provisions of the library's policies may lead to loss of library privileges and/or criminal penalties.
